## LANDLORD STANDARD FEES & CHARGES

When we introduce a tenant who enters a tenancy with you the following fees and charges will be payable

### LETTING COMMISSION

Tenant Find / Let Only Fee in accordance with Landlord Terms of Business

- Sole Agency - 9.6% incl VAT / 8% plus VAT
- Multi Agency – 12% incl VAT / 10% plus VAT

### RENT COLLECTION

Collecting and remitting rent received.

- 1.2% incl VAT / 1% plus VAT

### PROPERTY MANAGEMENT

Fees are taken in accordance with rent payments.

- 6% incl VAT / 5% plus VAT

### TENANCY AGREEMENT FEE

For administration including tenant referencing, Right to Rent Checks, and drawing up the tenancy agreement.

- £330 incl VAT / £275 plus VAT

### RENEWAL OF TENANCY COMMISSION

If the tenancy is renewed with the Tenant in accordance with the Landlord's Terms of Business

- Sole Agency - 8.4% incl VAT / 7% plus VAT
- Multi Agency – 10.8% incl VAT / 9% plus VAT

### RENEWAL AGREEMENT FEE

For negotiating a renewal and drawing up a renewal agreement

- £150 incl VAT / £125 plus VAT

### SHORT LETS

Tenant Find / Let Only for tenancies under six months.

- 24% incl VAT / 20% plus VAT

### HMRC Tax Returns

For Non-Resident Landlords

- £240 incl VAT / £200 plus VAT

### SUPERVISION OF MAJOR WORK / REPAIRS

To arrange major works & refurbishment

- 12% of total account incl VAT / 10% plus VAT
